The agenda for each GCP refresher training session was :

- Overview of ICH-GCP and Role and responsibilities of Investigator and Sponsor
- Supply and Handling of Investigational Products
- Role of Ethics Committee and Informed Consent Form
- Role of Quality Assurance: Procedures & Systems

The refresher training sessions were meant to reinforce the importance of concepts covered in the external training on GCP conducted every year, with the key aim that the participants have up to date knowledge & Skills to implement GCP when they return to their workplace which would ensure the rights, safety and well-being of patients and the quality of the research at Veeda CR.
